On August 13, 2020, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Comcast of Maine/New Hampshire, Inc. (Comcast), Consolidated Communications of Northern New England Company, LLC (Consolidated), and Commission Staff (Staff).

Following the prehearing conference, Comcast, Consolidated, and Staff met in a technical session and agreed upon the following initial procedural schedule, which Staff submitted to the Commission by letter dated August 14, 2020:

Data Request Responses	August 28, 2020
Technical Session ¹	September 2, 2020, at 10:00 a.m.
Stipulation of Facts Submission	September 4, 2020

Staff noted in its August 14 letter that the parties will attempt to develop a more comprehensive procedural schedule during the September 2 technical session.
