The intervenors respectfully request to **withdraw** the Motion to Dismiss that was filed electronically via the service lists for the DW 20-112 docket on 8/30/21. It has come to our attention that we may have erred in our verbiage while making our point. What we seek is actually a *WITHDRAWAL* of the rate case DW 20-112, by the Petitioners, in a good faith effort (non-QUID-PRO-QUO as currently proposed in DW-21-090), to come to a reasonable resolution of DW 21-090, by PUC standards.
