Petition to Approve Approval of Permanent Rates and Proposed Tariff Revisions

Dear Ms. Howland:

Pursuant to Puc 1604.02(a)(1) the company submits this cover letter accompanying the electronic copy of the Petition for the above-referenced matter. Pursuant to the Commission's March 17. 2020 letter citing to the COVID-19 emergency, the Company will not file any paper copies. The Company will maintain the original paper copy of this submission and file accordingly upon further notice from the Commission.

A summary of the requested rate relief and the nature and magnitude of the requested changes is as follows:

1. The company seeks rate relief for the first time since 2017. (See docket DW 17-118). Specifically, the company seeks to establish rates at the following:

The projected volumetric increase for single-family residential customers is based on a proposed two-tier rate. Those customers that use up to 400 cubic feet per month will increase from \$6.11 to \$6.83 per 100 cubic feet. Those that use more than 400 cubic feet per month will increase from \$6.11 to 10.24 per 100 cubic feet.

All other non-single-family residential customers will increase from \$6.11 to 9.31 per 100 cubic feet. The existing charge for a 5/8" customer, which is about 98% of all customers, will increase from \$10 to \$16.33 per month.

The Temporary Rate to become effective December 15, 2020 on a service rendered basis, would as follows:

The total number of customers is 3,857 with annual revenues of \$485.040. On a per general customer basis, the average costs would go from \$557.00 to \$642.21, an increase of \$85.21 or 15.30%

2. To revise the Company's tariff to reflect these new rates.

The magnitude of this change relates chiefly to the company's participation in the Southern New Hampshire Regional Water Project. The project will allow the company to connect to the Manchester Water Works water supply to provide this water to both the company's core system customers but also the town of Plaistow to alleviate water contamination in the town. The magnitude of this change also includes completion of a 1-million gallon water storage tank, and converting the company's core system pump stations from chlorine disinfection systems to chloramine sanitation systems as part of the Project. It has been about 3 years since rates were adjusted, and that the proposed rate increase will cover increased costs over the last 3 years plus improvements and additions to the infrastructure, increased labor costs, and other expenses.
