Dear Chairman Goldner:

A hearing was held in this docket on April 12, 2023. At that time, it was discovered that when Hampstead Area Water Company, Inc. ("HAWC" or "the Company") marked the Step I Settlement Agreement as Exhibit 20, the Company inadvertently cut off the bottom of Attachment B, Step 1 Schedule 1, Bates Page 0030. *Compare* Settlement Agreement and Attachments filed into the docket on January 25, 2023 *with* Exhibit 20, Bates Page 0030.

At hearing, testimony established that the Step I Settling Parties (HAWC, the New Hampshire Department of Energy, and the Town of Atkinson) intended the omitted portion of Attachment B to be included in Exhibit 20. For clarity, the Commission directed the Department of Energy ("Department" or "DOE") to file what was referenced as an "updated" Attachment B, Step I, Schedule 1. The Department has attached the updated Attachment B, Step I, Schedule I, marked "Exhibit 20a" for the Commission's convenience. Exhibit 20a includes that portion of Attachment B, Step I, Schedule I that was inadvertently omitted. Exhibit 20a has been marked with the same Bates Page Number as the page it replaces in Exhibit 20, including an "R" for "revised," i.e., "R0030."

The Department respectfully requests that the Commission accept Exhibit 20a, as conforming to the Commission's directive at hearing. See attached Exhibit 20a.

Consistent with the Commission's current practice, this letter is being filed solely in electronic form.
