**Amendment to Interconnection Agreement Between
TDS Telecom and Level 3 Communications, LLC**

AFFIDAVIT OF COMPLIANCE

NOW COMES Paul J. Phillips, upon oath, being duly sworn, and states as follows:

1. I represent TDS Telecommunications, LLC d/b/a TDS Telecom (“TDS”), a local exchange carrier that is a party to an Interconnection Agreement with Level 3 Communications, LLC (“the Level 3 ICA”).
2. On September 28, 2023, TDS submitted an Amendment to the Level 3 ICA (the “ICA Amendment”) to the Public Utilities Commission (“Commission”) for approval in accordance with 47 U.S.C. § 254(e)(1).
3. On January 5, 2024, the Commission issued Order No. 26,926, an Order *Nisi* approving the ICA Amendment pending compliance with certain conditions as set forth in the Order *Nisi*.
4. On February 15, 2024, TDS requested an extension of the compliance deadlines set forth in Order No. 26,926, which no party opposed.
5. On March 22, 2024, the Commission issued Order No. 26,983, extending the compliance deadlines set forth in Order No. 26,926, and requiring TDS:
 - a. To publish copies of Orders No. 26,926 and 26,983 on TDS’s website no later than March 29, 2024; and
 - b. To document such website publication by Affidavit filed with the Commission by April 5, 2024.
6. On March 28, 2024, TDS published copies of Orders No. 26,926 and 26,983 on its website, which are accessible by clicking on the URL links below:


