On behalf of Commission Staff (Staff) in this proceeding, enclosed please find Staff's response to the Commission's record request made during the May 10, 2021 hearing in the above matter. Specifically, the Commission asked Staff to file a corrected version of Attachment A, Schedule 1 (Bates Page 10), 'Calculation of PEU's Share of City Bond Revenue Requirement (CBFRR)' of Exhibit 2, 'DW 20-156 Settlement Agreement on Temporary Rates,' initially filed in this docket by Pennichuck East Utility, Inc. (PEU) on April 27, 2021, to remove all erroneous references to 'PWW' and replace them with references to 'PEU.'

The requested corrections are included in the attached document, premarked at the May 10, 2021 hearing as Exhibit 4. Staff's corrections replace erroneous references to PWW with references to PEU. No additional substantive corrections or changes were made to the corrected page.
