Procedural Order Re: Record Requests

Under the authority granted in RSA chapter 365, including RSA 365:15, the Commission requests Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) supplement the evidentiary record in this proceeding. Specifically, please respond to the following requests and supplement the record on or before the close of business on March 17, 2023:

Record Request 1: Refer to Exhibit 23.

Please provide the data on the number of customers on the Interruptible Rate (IR) classes over the past 10 years. Please indicate the annual number of days over the past ten years, when Eversource did interrupt service for those customers, and provide data on the extent of interruption (in kWhs) implemented during those events.

Record Request 2: Refer to Exhibit 24.

- a. What is Eversource's vision for AMI deployment in New Hampshire over the next five-years?
- b. Please provide a description of Eversource's AMI deployment in other jurisdictions.

Record Request 3: Refer to Exhibit 25.

Please provide substation, circuit, breaker-level and/or facility-level information identifying the location and system granularity of investment need.




