

INTERCONNECTION AGREEMENT

This Interconnection Agreement (this “Agreement”) is made effective on the 1st day of October, 2020, and is between TDS Telecommunications LLC, as agent for the New Hampshire operating company(ies) listed on Appendix A (“TDS TELECOM”) and Broadview Networks, Inc., a New York corporation; Earthlink Business, LLC, a Delaware limited liability company; and Paetec Communications, LLC, a Delaware limited liability company; all with principal place of business at 4001 Rodney Parham Road, Little Rock, AR 72212 (collectively “CLEC”).

WHEREAS, the Telecommunications Act of 1996 (the “Act”) was signed into law on February 8, 1996;

WHEREAS, Section 252(i) of the Act requires TDS TELECOM to make available any interconnection, service, or network element provided under an agreement approved by the appropriate state regulatory body to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety; and

WHEREAS, CLEC has requested that TDS TELECOM make available, in its entirety, that certain Interconnection Agreement entered into between TDS TELECOM and Level 3 Communications, LLC (“Level 3”) dated as of August 15, 2020 (“Level 3 Interconnection Agreement”).

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, CLEC and TDS TELECOM hereby agree as follows:

1. CLEC and TDS TELECOM shall adopt in its entirety the Level 3 Interconnection Agreement, as filed on August 27, 2020 with the New Hampshire Public Utilities Commission in Docket No. DT 20-138. The Level 3 Interconnection Agreement is attached hereto as Exhibit 1 and incorporated herein by this reference.
2. The term of this Agreement shall be from the effective date as set forth above and shall expire as set forth in Section 5 of the Level 3 Interconnection Agreement.
3. Every notice, consent, approval or other communications required or contemplated by this Agreement shall be in writing and shall be delivered in the case of CLEC to:
