On October 27, 2020, Energy Edge Consulting, LLC (Energy Edge) submitted an application with the Commission to register as a provider of electric aggregation service.

Commission Staff filed a memorandum on November 3, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 2000. Staff recommended that Energy Edge's registration application be approved for a two-year term.

Your application for registration is approved effective as of November 3, 2020, under Puc 2003.05(g)(1). The registration is for a term of two years and expires at the close of business on November 3, 2022. Pursuant to Puc 2003.06(a), you must submit your renewal application at least 60 days prior to the expiration of the approved registration term, on or before September 4, 2022.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.
