Procedural Schedule

To the Parties:

On May 3, 2021, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Lakes Region Water Company, Inc. (the Company) and Commission Staff (Staff). The Lake Ossipee Village Homeowners (LOVH) filed a petition to intervene on behalf of certain homeowners of the group, which the Commission took under advisement, but granted for the limited purpose of the May 3 prehearing conference and technical session. Carol E. Stansell participated in the prehearing conference and technical session on behalf of these members of the LOVH.

Following the prehearing conference, the Company, Ms. Stansell, and Staff met in a technical session and agreed upon the following schedule, which Staff submitted to the Commission by letter dated May 7, 2021:


