Dear Director Howland:

Enclosed for filing with the Commission please find Public Service Company of New Hampshire d/b/a Eversource Energy's replacement petition and exhibits in Docket 20-191, encompassing the following changes:

Changes to the Exhibits:

- 1. Global Changes to Exhibits 2-7:
 - a. Scale bars have been added
- 2. Exhibit 5:
 - a. Wire clearance dimension and horizontal dimension from proximate structure to vertical clearance dimension has been added for state land crossing on north side of North Branch River (map 214, Lot 34).
 - b. Wire clearance dimension and horizontal dimension from proximate structure to vertical clearance dimension has been added for state land crossing on south side of North Branch River and Structure 30 (map 214, Lot 103, Map 214, Lot 39).
 - c. Span distance between Str 38 and 39 has been changed from 732' to 732.2'.
 - d. Distance for "Edge of State Land" has been changed from 863.8' to 863.5'.
- 3. Exhibit 6:
 - a. "Edge of Boundary" added to the southern edge of State Land adjacent to Algonquin Ave.
 - b. Horizontal dimension added from Structure 40 to edge of state land.

Changes to the Replacement Petition Narrative:

- 1. P. 2 Removed references to site location exhibits 2A, 3A, 6A and 7A as well as associated Exhibits. Replaced said Exhibits with site location narrative descriptions of all crossing locations.
- 2. P. 3 Added explanation and clarification to the status of Structure 5 replacement.

- 3. P. 5 Added explanation of the removal of the existing underbuilt communication fiber across the entire line.
- 4. P. 8 Footnote added disclosing slight differences in structure locations, structure elevations, span distances and clearance dimensions from recent petitions submitted, DE 19-134 and DE 19-149, arising from the incorporation of as-built information in the subject replacement.
- 5. P. 8, VI Structure span has been changed from 1589 to 1589.2
- 6. P. 8, VI State Owned Land Span has been changed from 903' to 902.7'.
