Enclosed for filing with the Commission please find Public Service Company of New Hampshire d/b/a Eversource Energy's replacement petition and exhibits in Docket 20-211, encompassing the following changes:

**Changes to the Exhibits:**

1. Exhibit 2 through 5: Clearance criteria for state lands has been changed from "Roads, streets, and other areas subject to truck traffic" to "Other areas traversed by vehicles, such as cultivated, grazing, forest, and orchard lands, industrial sites, commercial sites, etc."
2. Exhibits 1, 6, 7 and 8: No changes from original submission but they are included herewith to encompass a complete set of updated Exhibits.

**Changes to the Petition Narrative:**

1. P. 1 & 2 - Clarifies an inconsistency in underlying Docket 19-172 wherein the Docket 19-172 petition incorrectly described Structure 49 as a wood to steel replacement, when in fact Structure 49 was replaced with wood as depicted on the supporting exhibit in said docket. In the present Docket 20-211, Structure 49 is now scheduled for wood to steel replacement.
2. P. 3 – Added narrative description of site location for State owned land and public water crossing spans in place of reference to satellite imagery Exhibits 5A, 6A, 7A and 8A; omit Exhibits 5A, 6A, 7A and 8A.
3. P. 5, I. - Revised section to include entire state land span between Structure 26 thru 33.
4. P. 5, II. – Section referring to state land crossing has been removed as it has been incorporated in revised P. 5, I.
5. P. 7 – Reference to clearance criteria over state land has been changed from "roads, streets and other areas subject to truck traffic" to "other areas traversed by vehicles, such as cultivated, grazing, forest, and orchard lands, industrial sites, commercial sites, etc."
