Dear James,

I am forwarding you this letter in reference to our prior discussion on July 12, 2022. By way of this formal letter, I am informing you that Bodwell Waste Services, "BWSC" will likely not be requesting any modification to the existing loan.

BWSC presently has a request pending before the N.H. Public Utilities Commission to terminate the franchise and BWSC's service to customers. If approved, we will be donating the assets of "BWSC" to the City of Manchester and the Town of Londonderry, whereupon the City and Town will provide waste services directly to the customers, without BWSC's involvement. We will also be paying off the current loan and look forward to the termination of "BWSC". BWSC hopes to have approval in time to terminate service in early 2023 but BWSC will keep you informed of the official approved termination date.

THAT, I Robert S. LaMontagne, President of Bodwell Waste Services Corp. a regulated public utility under RSA 362:4 with a business location of 317 South River Road in Bedford, New Hampshire, 03110.

THAT, I am providing sewer services to certain parts of the City of Manchester and Town of Londonderry, New Hampshire.

THAT, on July 12, 2022, I met with James Gallagher, Sr. VP., Senior Commercial Lending Officer of Merrimack County Savings Bank and told him that the City of Manchester and Town of Londonderry will be taking over all of the assets of Bodwell Waste, if approved by the N.H.
