
**2020 Annual Storm Fund Report**

**Procedural Order Re: Rescheduled Hearing**

In Order No. 26,514 (September 1, 2021), issued in Docket No. DG 06-107, the Commission granted Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty's (Liberty or the Company) request for rehearing regarding the Commission's April 23, 2021 decision denying Liberty's request to recover \$706,838 from the Company's Storm Fund. The Commission scheduled a hearing in Docket No. DG 06-107 on October 4, 2021 on the issues and evidence related to Liberty's 2019 recovery from the Storm Fund. On September 30, 2021, the Commission issued a letter postponing the October 4, 2021 hearing due to scheduling conflicts.

The hearing in Docket No. DG 06-107 has been rescheduled to Thursday, July 21, 2022, starting at 9:00 a.m. On this date and time, the Commission also schedules a hearing in Docket No. DE 21-073 to address any issues that may arise relating to Liberty's 2020 recovery from the Storm Fund. One day has been allotted to address both year's Storm Fund recoveries. The hearing shall be conducted in person, in accordance with the attached hearing guidelines.
