**Procedural Order Re: Request for Extension of August 19, 2022 Deadline**

The Commission held a hearing on July 21, 2022, on the issues and evidence related to Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty's (Liberty or the Company) 2019 recovery from the Company's Storm Fund, as well as any issues relating to Liberty's 2020 recovery from the Company's Storm Fund. See Procedural Order dated May 23, 2022. During the hearing, the Commission requested that Liberty file a brief and respond to a record request by August 5, 2022, with the New Hampshire Department of Energy (DOE) to file a reply brief and respond to a record request by August 19, 2022. Transcript of July 21, 2022 Hearing at 316, 317-319.

Liberty submitted its filings on August 5, 2022. On August 18, 2022, the DOE filed a request to extend the August 19 deadline to August 24, 2022. The DOE stated that it was unable to comply with the August 19 deadline due to other matters and represented that Liberty assented to its request. It asserted that the requested extension would not unduly delay these proceedings or adversely affect Liberty's rights, but that the DOE would be caused undue hardship unless its request was granted.

The DOE's request for an extension is GRANTED. See N.H. Admin. R., Puc 202.04.  
The DOE shall file its reply brief and record request response on or before by Wednesday, August 24, 2022.
