

Procedural Order Re: Hearing on Settlement Agreement

The Commission issued a procedural order on July 12, 2022, which extended the deadline for Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) to file a status report to July 15, 2022. On July 18, 2022, Liberty notified the Commission that it, the New Hampshire Department of Energy, and the Office of the Consumer Advocate had reached a settlement agreement and asked the Commission to schedule a hearing to review the settlement agreement. Also on July 18, 2022, counsel for intervenor Terry Clark filed a notice of concerns. The settlement agreement was filed on July 20, 2022.

A hearing is scheduled on Thursday, August 18, 2022, at 9:00 a.m., during which the Commission will consider the settlement agreement, as well as any responses to it that are filed. Responses to the settlement agreement shall be filed no later than August 11, 2022. One day is allotted for the hearing, which shall be conducted in accordance with the attached hearing guidelines.
