
**Procedural Order Re: Request for Remote Participation Filed by Clean Energy NH**

The Commission GRANTS Clean Energy New Hampshire's (CENH) request, filed on February 7, 2024, that its representative, Ethan Goldman, who is based in Vermont and, as represented by CENH, unable to travel to Concord at this time, be permitted to participate remotely during the status conference scheduled on February 8, 2024 in the above-captioned docket. Given the short amount of time remaining before the February 8 status conference, the Commission waives New Hampshire Code of Administrative Rules, Puc 203.07(e). The filing of a separate request will be required for any other parties or witnesses wishing to appear remotely.
