**Request for Change in Rates – Step I**

**Procedural Order Re: Request for Clarification**


On August 18, 2023, Hampstead Area Water Company, Inc. (HAWC) filed a request for clarification of Order No. 26,874 (August 16, 2023), in which the Commission denied Ms. Steele’s motion for rehearing of Order No. 26,809 (April 28, 2023) and reaffirmed the Commission’s approval of “the recovery of the MSDC [Merrimack Source Development Charge] fee in Step I rates pursuant to the terms of Order Nos. 26,809 and 26,635.” The Commission had suspended Order No. 26,809 on June 14, 2023, in accordance with RSA 365:21, “pending further consideration of Ms. Steele’s motion for rehearing . . . .” Order No. 26,846.

The Commission GRANTS HAWC’s request and clarifies that the suspension of Order No. 26,809 is lifted, consistent with Order No. 26,874, so that the order of suspension, Order No. 26,846, is no longer in effect. As Ms. Steele’s motion for rehearing has been denied, Order No. 26,809, with all of its provisions, is in full force and effect by operation of law. The Commission waives New Hampshire Code of Administrative Rules, Puc 203.07(e).
