On October 31, 2022, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty), with the assent of the New Hampshire Department of Energy, filed a letter requesting approval of the following proposed amended procedural schedule:


Liberty Supplement to Least Cost Integrated Resource Plan (LCIRP)	December 12, 2022
Discovery on LCIRP Supplement Responses	December 20, 2022
Settlement Conference	January 6, 2023
Settlement/Recommendation	January 20, 2023
Hearing Dates, Two Full Days	February 3, 2023 After February 13, 2023

The proposed procedural schedule would amend the procedural schedule approved on October 10, 2022.

No objections to the proposed amended procedural schedule [motion] have been filed. It has been determined that this schedule is in the public interest and, therefore, the foregoing amended procedural schedule is approved.

The December 7 and 8, 2022 hearing dates have been rescheduled to Tuesday, February 28, 2023, and Wednesday, March 1, 2023, starting both days at 9:00 a.m. The hearings will be conducted in person, in accordance with the hearing guidelines issued on June 13, 2022.
