**Petition for Approval of Franchise Expansion, Acquisition of Assets,
and Application of Existing Rates**

Procedural Order Re: Joint Motion for Reconsideration

On December 6, 2021, Aquarion Water Company of New Hampshire, Inc. (Aquarion) and Wiggin Way/Winterberry Homeowners' Association (Wiggin Way) filed a joint motion for reconsideration of the Commission's November 17, 2021 procedural order, in which the Commission established a briefing schedule. Aquarion and Wiggin Way requested the Commission to revise the briefing schedule either to provide for simultaneous briefing by all parties or to allow Aquarion, Wiggin Way, and the New Hampshire Department of Energy (Energy) to file briefs responding to the reply briefs of the Towns of Hampton and North Hampton (the Towns).

The Towns filed an objection to the joint motion for reconsideration on December 13, 2021. In their objection, they requested that, if the Commission grants the motion, it modify the existing briefing schedule to allow the parties to submit initial briefs and/or testimony on January 31, 2022 and reply briefs and/or testimony on February 14, 2022. The Town of North Hampton represented that Aquarion and Wiggin Way assented to this proposed modification and Energy took no position.

Accordingly, Aquarion's and Wiggin Way's joint motion for reconsideration is GRANTED, and the briefing schedule contained in the November 17, 2021 procedural order is revised as follows:

*Initial Brief(s) and/or Testimony to be filed by all parties January 31, 2022

*Reply Brief(s) and/or Testimony to be filed by all parties February 14, 2022

*Briefs shall be limited to 10 pages each.

Hearing on the Merits February 23, 2022
