
**Procedural Order Re: Motion for Remote Participation**


The Commission scheduled an in-person prehearing conference in this matter on November 17, 2022. On November 10, 2022, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty) filed a late request for remote participation by two Liberty employees based in Joplin, Missouri, Aaron Doll and Brad Parker, due to travel costs. As of today's date, no responses to Liberty's motion have been filed.

Given the limited time remaining before the November 17 prehearing conference, the Commission waives the 10-day objection period under New Hampshire Code of Administrative Rules, Puc 203.07(e). See N.H. Admin. R., Puc 201.05. The Commission finds that Liberty has provided good reason for Mr. Doll and Mr. Parker to appear remotely on November 17. Therefore, Liberty's motion for remote participation is GRANTED, and a hybrid hearing format will be used for the November 17 prehearing conference to accommodate Mr. Doll and Mr. Parker only. Any other parties or witnesses wishing to appear remotely at the prehearing conference are required to file a separate request.
