Request 1

Please explain the reasons for the summer rate increase in the context of the declining NYMEX prices.

Request 2

Please explain (with supporting schedules) the under collections included in the updated summer 2023 rates.

- a) Do the under collections match the Summer 2022 reconciliation filed on February 2, 2023 in Docket No. DG 21-130? If not, please explain the differences.
- b) Did DOE complete an audit of the Summer 2022 reconciliation? If yes, please, provide a copy of the final audit report.

Please provide live Excel versions of all supporting schedules used to develop the responses.
