**New Hampshire Code of Administrative Rules PART 206
Alternative Regulation**

ORDER OF NOTICE

The Commission hereby provides notice of its intent to readopt without amendment N.H. Code Admin. Rules Puc PART 206, related to Alternative Regulation. The readoption of PART 206 of the Puc ch. 200 Rules of Practice and Procedure is a discreet rulemaking action. But for this action, the PART 206 rules would expire April 9, 2023. Future rulemaking action or actions related to other parts of the Puc 200 Rules of Practice and Procedure will be separately initiated and noticed in this docket as a part of forthcoming updates to the Commission's non-lapsing rules of practice and procedure.

A Notice of Rulemaking (Notice), as required by RSA 541-A:6, was published in New Hampshire's Rulemaking Register No. 14, dated April 6, 2023. In addition, a copy of the Notice has been sent to all persons who have made a timely request for advance notice of Commission rulemaking proceedings, all persons on the service list in the above-captioned docket, and shall be posted on the Commission's bulletin board and website. Pursuant to Puc 205.05 and RSA 541-A:11, a public hearing will be held at the Commission on May 10, 2023 at 1:00 p.m. in Hearing Room A. Written comments will be accepted through May 18, 2023. The Notice as published in New Hampshire's Rulemaking Register and the Commission's initial proposal for rulemaking are posted to the Commission's website at

ORDERED, that a Public Hearing, pursuant to RSA 541-A:11, to hear comment on the Commission's proposal to readopt without amendment N.H. Code Admin. R. PART 206 will be held at 21 South Fruit Street, Suite 10, Concord, New Hampshire in Hearing Room A, on May 10, 2023 at 1:00 p.m., and that the deadline for submission of materials in writing or by e-mail shall be May 18, 2023, as set forth in the Notice; and it is

FURTHER ORDERED, a copy of this Order of Notice shall be posted on the Commission's website and bulletin board within two business days of this order.
