
**Potential Jurisdictional Conflicts Related to Authorization of
Pilot Programs Under RSA 362-A:2-b**

Procedural Order Re: Request for Remote Participation

On August 24, 2023, Public Service Company of New Hampshire d/b/a Eversource Energy, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty, and Unitil Energy Systems, Inc. (collectively, the Joint Utilities) and the Community Power Coalition of New Hampshire (CPCNH) filed a joint request for their respective outside counsel to appear remotely at the September 14, 2023 hearing. The parties represent that both the Joint Utilities' counsel, Jennifer Key of Steptoe & Johnson, and CPCNH's counsel, Michael Postar and Gelane Diamond of Duncan, Weinberg, Genzer, Pembroke, P.C., are based in Washington, D.C. and that it would therefore be inconvenient for them to travel to New Hampshire for the one-day hearing. No party objected to the joint request. The Commission GRANTS the request with respect to Attorneys Key and Postar. With respect to Attorney Diamond, the Commission already stated that she could appear remotely in the July 31, 2023 order scheduling the hearing and no additional approval is required.

The Commission notes that only individuals who have received permission may appear remotely. The filing of a separate request is required for any other parties or witnesses to appear remotely at this hearing.
