
Prehearing Order

A prehearing conference in this matter was held on May 18, 2023. Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty), the New Hampshire Department of Energy and the Office of the Consumer Advocate appeared. The matters raised at the prehearing conference included the preliminary positions of the parties on Liberty's petition, a procedural schedule for the remainder of the proceeding, and the DOE's request that the Commission take administrative notice of a portion of the record of other proceedings before the Commission (see below). This order addresses matters raised.

As determined at the prehearing conference, a deadline of May 31, 2023, is established for the parties to file a proposed procedural schedule in this matter. Administrative notice was also taken of the following relevant portions of the record of other proceedings before the Commission:
