**Procedural Order Re: Motion for Waiver and/or Determination of  
Substantial Compliance with Notice Requirements**

On July 24, 2023, the Commission issued an order of notice, which required the petitioning utilities to publish it on their individual websites no later than July 26, 2023. Unitil Energy Systems, Inc. (UES) filed a motion on July 27, 2023 requesting that the Commission waive this requirement or find that UES substantially complied with the notice requirement by posting a copy of the order of notice on its website one day later, on July 27, 2023, as shown in the attached "Affidavit of Publication." No objection to UES's motion was filed.

The Commission finds that UES substantially complied with the notice requirement contained in the July 24 order of notice, so that all interested parties received reasonable notice of this adjudicative proceeding, including the prehearing conference scheduled on August 17, 2023. *See* N.H. Admin. R., Puc 203.12(b). Therefore, UES's motion is GRANTED.
