Procedural Order Re: Briefing Schedule

During the January 8, 2024 hearing on issues raised by the New Hampshire Department of Energy's motion for rehearing of Order 26,899 (October 31, 2023), the Commission stated that the parties would have an opportunity to file briefs regarding the legality, under RSA 378:29 and all other applicable statutes, of a temporary rate effective date of October 1, 2023 in this proceeding, as well as any other relevant legal issues. Initial briefs shall be filed by January 23, 2024, and reply briefs are due no later than January 30, 2024.
