**Procedural Order Re: NHEC Motion for Waiver and/or Determination of  
Substantial Compliance with Notice Requirements**

On August 25, 2023, the Commission issued a notice of adjudicative proceeding and hearing, which required the petitioning utilities to publish it on their websites no later than August 29, 2023. On September 1, 2023, New Hampshire Electric Cooperative, Inc. (NHEC) filed a motion requesting that the Commission waive this requirement or find that NHEC substantially complied with the notice requirement by posting a copy of the notice on September 1, 2023. No party objected to NHEC's motion.

The Commission finds that NHEC substantially complied with the notice requirement contained in the August 25 notice to provide all interested parties reasonable notice of this adjudicative proceeding and the September 21, 2023 hearing. See N.H. Admin. R., Puc 203.12(b). Therefore, NHEC's motion is GRANTED.
