Request for Change in Rates
Postponement of August 23, 2021 Hearing

To the Parties:

A hearing was scheduled on August 23, 2021 by secretarial letter dated June 28, 2021. On August 16, 2021, on behalf of Atkinson Area Waste Water Recycling, Inc., the New Hampshire Department of Energy (Energy) filed a letter requesting the Commission to postpone the August 23, 2021 hearing to a new date after September 27, 2021. Energy stated that a postponement was necessary, because new issues recently arose, which require the parties to have further discussions and revise multiple documents. Energy's letter also refers to Docket No. DW 20-091, but no hearing in that docket has been noticed or scheduled.

Energy's request related to DW 20-071 has been granted. *See* N.H. Admin. R., Puc 203.13(c). The hearing on August 23, 2021 has been postponed to Thursday, September 30, 2021, beginning at 9:00 a.m. It shall be conducted in accordance with the attached "Hearing Guidelines" and supplemental order of notice. No action can be taken in Docket No. DW 20-091 at that time, however, because no hearing has been requested, noticed, or scheduled in that docket. Any recommendation or requests related to Docket No. DW 20-091 should be made in that docket.
