To the Parties:

On September 4, 2019, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Northern Utilities, Inc. (Northern), the Office of the Consumer Advocate (OCA), and Commission Staff (Staff). No petitions to intervene were filed.

Following the prehearing conference, Northern, the OCA, and Staff met in a technical session. Staff has proposed the following procedural schedule, which was submitted to the Commission by letter dated September 16, 2019:

Hearing	February 14, 2020


No party has objected to the proposed schedule.
