To the Parties:

Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty) procures default energy service for its medium/large commercial and industrial customers (Large customers) and its residential and small commercial customers (Small customers) using a solicitation process which the Commission approved in Order No. 24,577 (January 13, 2006), issued in Docket No. DE 05-126, and most recently modified in Order No. 25,806 (September 2, 2015), issued in Docket No. DE 15-010. On December 16, 2019, Liberty filed a petition for approval of 100 percent of its default service power supply requirements for its Large and Small customers for the six-month period beginning February 1, 2020, as well as attachments showing the results of the solicitation in rates. In support of its petition, Liberty filed the testimony and related exhibits of John D. Warshaw and the Technical Statement of David B. Simek.

The Commission will hold a merits hearing on Wednesday, December 18, 2019, at 1:30 p.m., during which the Commission will hear the testimony of Mr. Warshaw and Mr. Simek.
