To the Parties:

By secretarial letter dated October 1, 2019, the Commission approved the parties' proposed procedural schedule, which scheduled a hearing on March 18, 2020. The Commission rescheduled this hearing to March 17, 2020 by secretarial letter dated January 28, 2020. On March 12, 2020, Commission Staff (Staff) filed a letter requesting the March 17 hearing to be rescheduled to May 27, 2020, at 10:00 am, noting that all parties have assented to the request.
