To Whom It May Concern:

On March 13, 2020, Governor Christopher T. Sununu declared a state of emergency related to the spread of COVID-19. As part of its efforts to mitigate the spread of COVID-19, the New Hampshire Public Utilities Commission has decided to temporarily change the manner in which public utilities are required to post notice of proposed rate changes.

Public utilities are normally required to publish a copy of the Commission's order of notice in a newspaper of general circulation in the utility's franchise area. *See* N.H. Admin. R., Puc 1604.03(e). The Commission has decided that its rules and the present circumstances justify a temporary waiver of Puc 1604.03(e). During the period of the state of emergency, the Commission will instead post orders of notice, which normally provide notice of a hearing, at <https://www.puc.nh.gov/Regulatory/ordersofnotice.htm>. The Commission will also post hearings at https://www.puc.nh.gov/Regulatory/Commission_Calendar.pdf, and will provide notice of upcoming hearings by social media. In addition, public utilities will be required to post orders of notice on their company websites.
