Staff Report on April 8, 2020 Technical Session

To the Parties:

On January 24, 2020, the Commission issued a secretarial letter approving the parties' proposed procedural schedule, which provided for a technical session on April 8, 2020 and required Commission Staff (Staff) to file a report on the technical session and/or a further proposed procedural schedule by April 16, 2020. Following the remote technical session, which was attended by Omni Mount Washington Hotel, LLC (Omni), Abenaki Water Company, Inc. (Abenaki), Paul Mueller, representing Bretton Woods Property Owners Association, the Office of the Consumer Advocate, and Staff (referred to collectively as the Participants), Staff filed a report with the Commission on April 14, 2020.

In its report, Staff stated that the Participants agreed at the technical session to allow Omni and Abenaki additional time to update their prior discovery responses and to answer technical session data requests. Staff, on behalf of the Participants, requested leave to file an additional status report by April 24, 2020, along with a proposed revised procedural schedule.

The Commission has granted Staff's request. Accordingly, Staff shall file a status report and a proposed revised procedural schedule on or before Friday, April 24, 2020.
