Rescheduling May 27, 2020 Hearing

To the Parties:

By secretarial letter dated October 1, 2019, the Commission approved the parties' proposed procedural schedule, which scheduled a hearing on March 18, 2020. The Commission rescheduled this hearing to March 17, 2020 by secretarial letter dated January 28, 2020. On March 13, 2020, the Commission issued a secretarial letter granting Commission Staff's (Staff) assented-to request to reschedule the hearing to May 27, 2020.

On May 22, 2020, Staff filed a letter requesting the Commission to reschedule the May 27 hearing to June 26, 2020, noting that all parties assented to the request. Further, Staff stated that rescheduling the hearing would optimize the use of the parties' resources and would not unduly delay this proceeding.

Accordingly, the Commission has rescheduled the May 27 hearing to Friday, June 26, 2020, at 1:30 p.m. *See* N.H. Admin. R., Puc 203.13. The June 26, 2020 hearing will be conducted in accordance with the "Remote Hearing Guidelines" contained in the secretarial letter dated May 8, 2020.
