To the Parties:

On May 15, 2020, pursuant to a secretarial letter dated April 20, 2020, and issued in Docket No. DG 17-152, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) filed a letter requesting the Commission to schedule a technical session on June 3, 2020 with regard to both of the above-captioned dockets.
