On May 29, 2020, Resource Energy Solutions, LLC (Resource Energy) submitted an application with the Commission to renew its registration as a provider of electric aggregation service. On June 8, 2020, Resource Energy filed an update to their registration renewal, providing a list of other states they currently conduct business in.

Commission Staff filed a memorandum on June 16, 2020, in which it confirmed its review of the application and its conclusion that the application is complete. Staff recommended that Resource Energy's registration renewal application be approved for a two-year term, beginning on August 23, 2020, pursuant to Puc 2003.06(e)(1).

Your application for registration renewal is approved effective as of August 23, 2020 under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on August 23, 2022. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before June 24, 2022.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin.
