Dear Mr. Macksoud:

On August 27, 2020, AvidXchange, Inc. (AvidXchange) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on September 8, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Admin. R., Puc 3000. Staff recommended that AvidXchange's registration renewal application be approved for a two-year term, beginning on November 2, 2020.

The Commission has approved Staff's recommendation. Accordingly, AvidXchange's application for registration renewal is approved, effective as of November 2, 2020. The renewed registration is for a term of two years and expires at the close of business on November 2, 2022. Pursuant to Puc 3003.06(a), AvidXchange must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before September 3, 2020.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
