To the Parties:

On November 10, 2020, the Commission received the parties' comments and oral arguments concerning the Commission Staff's (Staff) and Office of Strategic Initiatives' (OSI) August 3, 2020 revised recommendation for use of the \$5.2 million Clean Energy Fund. The Commission has determined that further discussion and collaboration may result in a slightly modified recommendation with full support among the parties. Given the Settlement Agreement's<sup>1</sup> requirement for a collaborative process, a consensus recommendation is preferred.

As a result, the Commission directs the parties, including the OSI, to meet as soon as possible to discuss revisions to recommended programs and allocations. During the session, the parties should attempt to reach a consensus on the use of the Clean Energy Fund, while meeting the goals identified in the Settlement Agreement. Should a consensus emerge, the parties should report their agreement to the Commission for review and approval. Otherwise, the parties should advise the Commission that, notwithstanding further discussions, a consensus cannot be reached. Staff shall file a report with the Commission regarding the outcome of this stakeholder session on or before December 18, 2020.
