Dear Mr. Cartwright:

On March 5, 2021, Trusted Energy, LLC (Trusted) submitted an application to the Commission to renew its registration as a provider of natural gas aggregation services.

Commission Staff (Staff) filed a memorandum on May 25, 2021, summarizing its review of the application and recommending that a waiver be granted of the renewal application filing deadline under N.H. Admin. R., Puc 3003.06(a) and that Trusted's registration renewal application be approved for a two-year term, beginning on March 18, 2021.

The Commission has granted the recommended rule waiver, having found that it would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, under Puc 201.05. Accordingly, Trusted's application for registration renewal is approved, effective as of March 18, 2021. The renewed registration is for a term of two years and expires at the close of business on March 18, 2023. Pursuant to Puc 3003.06(a), Trusted must submit the next renewal application at least 60 days prior to the expiration of the approved registration term, on or before January 17, 2023.

Please be aware that registered providers of natural gas aggregation services are subject to specific requirements contained in N.H. Admin. R., Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
