Procedural Order Re: Motion Requesting Leave to Submit Brief

On September 28, 2021, Conservation Law Foundation (CLF) filed a motion requesting leave to submit a brief regarding whether Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities has complied with New Hampshire's Least Cost Integrated Resource Plan statutes and related legal issues. CLF asserted that briefing would help the Commission to decide the issues that will be presented at the hearing in this matter scheduled on October 6, 2021. It stated that it supported an expedited briefing schedule, which would require briefs to be filed shortly after the October 6 hearing. CLF represented that the other parties to this docket have no objection to its motion, and no objections have been filed.


