To the Parties:

On February 25, 2021, Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications-NNE (Consolidated) filed a letter requesting that the Commission continue the suspension of the procedural schedule ordered by secretarial letter dated December 11, 2020. Consolidated advised the Commission that the parties' settlement discussions were ongoing, and requested that the suspension remain in effect until April 30, 2021, by which date a status report will be filed. It stated that more time was needed for settlement discussions due to the number of parties involved and various scheduling conflicts.

The Commission has approved Consolidated's request. Accordingly, the Commission has continued suspension of the procedural schedule until April 30, 2021. A status report shall be filed on or before Friday, April 30, 2021.
